We've been unsuccessful in obtaining a meeting with you to discuss the future of the Center City Connector Project. We feel we have information that is critical in the decision making process and have attached the following for your review:

- A letter, signed by over 100 individuals and businesses in support of the completion of the project
- A graphic demonstrating the importance of connecting the large concentration of jobs, residents and low income housing

Lastly, the political calculations that drove major budget decisions for the project are much less relevant today, and may be more flexible, considering the current budget alternatives in front of the City. Many of the Streetcar coalition members would be willing to help the City revisit a host of cost saving solutions including station and maintenance base consolidation.
